Duration

This tenancy shall commence on __/__/20__ and shall remain valid for a fixed period of 11 (eleven) months, expiring on __/__/20__. The tenancy may be renewed by mutual agreement.

Rent & Payment Terms

The Tenant agrees to pay a monthly rent of Rs. _____ (Rupees _____ only), payable in advance on or before the 5th day of each English calendar month by bank transfer/UPI/cash/cheque.

Security Deposit

The Tenant has paid a sum of Rs. _____ (Rupees _____ only) as a refundable security deposit. This amount shall be refunded within 30 days of vacating the premises, after deducting dues such as unpaid bills and repair charges, if any, with proper receipts provided.

Utilities & Maintenance

Electricity, water, gas, and internet charges shall be borne by the Tenant as per usage. Society maintenance charges (if applicable) shall be paid by [Landlord/Tenant].

Repairs

Minor day-to-day repairs (such as replacement of bulbs, taps, or fixtures) shall be carried out by the Tenant. Major structural repairs (such as leakage, electrical wiring, or civil works) shall be the responsibility of the Landlord.

Termination & Notice

Either party may terminate this agreement by giving one month (30 days) prior written notice. In case the Tenant vacates earlier without notice, one month's rent shall be deducted from the security deposit.

Subletting & Guests

The Tenant shall not sublet, assign, or part with possession of the rented premises without the prior written consent of the Landlord. Guests may stay temporarily with the consent of the Landlord.

Jurisdiction

In case of disputes, the matter shall be subject to the jurisdiction of the courts at _____ (City/State).
